We thank you for your interest in **azpro** vehicle graphics and wraps. **azpro** prides itself in only producing the best quality service and elements involved from conception to final product. In order to proceed with the wrap and/or graphic installation to your vehicle, you must read and acknowledge each item by placing your initials on each line.

# BEFORE INSTALLATION

- \_\_\_\_\_ Pre-installation, the customer service rep or project coordinator pointed out dents, scratches, and other damages found on the vehicle. I do not hold **azpro** liable for any of those damages on the vehicle.
- \_\_\_\_\_ I have been explained and understand that the installation will reflect the condition of the paint of the vehicle.
- \_\_\_\_\_ I understand that any dents or scratches to the paint of the vehicle may be visible and appear as bubbles or wrinkles on the material.
- \_\_\_\_\_ I understand that seams and patches on the material may be necessary.
- \_\_\_\_\_ I understand the following area cannot be wrapped:
  - porous areas      • door jambs      • rubber molding      • caulking-silicone
  - windshield      • plastic trim      • driver/passenger windows      • chrome\*

\*Although chrome can be wrapped, **azpro** does not typically wrap it as it is considered an accent piece of the vehicle. If you would like the chrome wrapped, notify your customer service rep or project coordinator prior to the design/install process beginning.
- \_\_\_\_\_ I understand this is a vehicle wrap and the color of the vehicle may show in these areas unless specified and agreed upon at the time of sale.
  - door jambs      • behind bumpers      • in between bed & cab for pick-ups
  - door handles      • vents/hole-slats      • bottom pinch welds
- \_\_\_\_\_ While **azpro** makes every effort to ensure consistent colors, I understand that there may be some slight color variations from panel to panel and vehicle to vehicle.
- \_\_\_\_\_ I understand that vehicle wraps are meant to be viewed from 6-10 feet away.
- \_\_\_\_\_ I understand **azpro** will not be liable for any paint damage occurring during installation.

Upon completion of the install of the vehicle graphic and/or wrap, a 5-day bonding period is required to ensure that all conformed areas are set, the vinyl becomes relaxed, and the adhesives have had a chance to “wet-out” creating a maximized bond between vinyl and substrate. During this “bonding” period, any small bubbles or imperfections in the finish of the wrap may be reduced or completely eliminated. Washing the wrap during this period could jeopardize the integrity of the install. Any areas of concern should be brought to the attention of **azpro** after the initial bonding period as soon as they are noticed. Being proactive in the identification of potential problems is key to the longevity of the wrap.

*\* Take a moment to review the warranty and maintenance sheets provided by your **azpro** representative.*

# AFTER INSTALLATION

- I understand that the rear wiper should not be used if there is material on the window.
- I understand rear window should not be rolled down if material is on the window.
- The customer service rep or project coordinator has done a walk-through with me.
- I am satisfied with the final product.
- I understand that I am responsible for the maintenance of the vehicle wrap. Wear and tear, including but not limited to, scratches or nicks on the vinyl, will be fixed at my expense.
- I understand that high pressure washes may damage the material on my vehicle and this will compromise the integrity of the graphics which may cause them to fail prematurely.
- I understand that hand washing my vehicle is the best option to help keep my wrap looking its best and will allow me to get the full life out of my investment.
- I understand that extreme heat, extreme cold, snow, rain and air pollutants can quickly damage vinyl graphics. It is important to keep my vehicle out of harm's way as much as possible when not driving.
- I understand the importance of washing my vehicle after storms and/or rain due to the pollutants.
- I have been briefed on the aftercare responsibilities for my graphics.
- I understand that **azpro** will not be liable for any paint damage that may occur while the wrap is on the vehicle or when the wrap is removed from the vehicle in the future.
